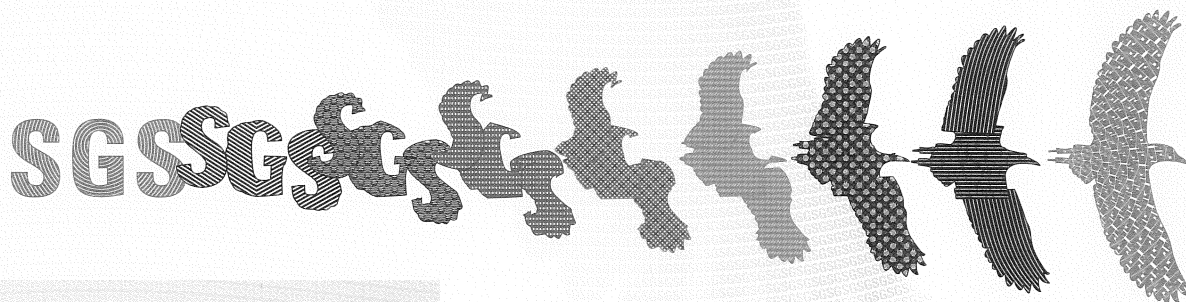

## EC Directive 89/686/EEC EC Type-examination

### PPE Product

Tyvek® IsoClean® model IC183B DS, clean processed, sterile non hooded protective coverall manufactured from spunbond polyethylene material with inside bound seams, with cuff, ankle and waist elastic, zipper and zipper flap. This coverall is available in twelve nominal sizes.

It is certified that the manufacturer's technical file and the above mentioned PPE have been assessed and found to be in accordance with the requirements of Council Directive 89/686/EEC. When examined the PPE satisfied the requirements in the relevant harmonized standards:

EN ISO 13982-1:2004 + A1:2010 (Chemical protective clothing providing protection to the full body against airborne solid particulates) for Type 5, limited wear life clothing;  
EN 13034:2005 + A1:2009 (Chemical protective clothing offering limited protective performance against liquid chemicals) for Type 6, limited wear life, full body protection;

EN 14126:2003 (Protective clothing against infective agents) for Type 5-B, 6-B, limited life, full body protection.

In addition the PPE satisfied the requirements of ISO 16602:2007/Amd.1:2012 (Protective clothing for protection against Chemicals) for Type 5: Chemical protective clothing providing protection against airborne solid chemicals and Type 6: Chemical protective clothing with "limited protective performance against liquid chemicals".

In addition with one exception the PPE satisfied the requirements of EN 1073-2:2002 (Protective clothing against particulate radioactive contamination - Non-ventilated clothing) with a performance classification of TIL Class 1. The exception is that clause 4.2 specifies that the minimum puncture resistance should be level 2, but the fabric used has a puncture resistance classification of level 1.

The manufacturer's information notice (Tyvek® IsoClean® September 2015/1/V1), in English, has been inspected and found to have addressed all of the relevant requirements of the standards. However, the detailed content of the information notice is the responsibility of the manufacturer, as are translations into other languages.

This certificate is issued on the strict condition that appropriate checks on manufactured PPE, as detailed in Article 11 of the Directive are implemented and maintained while the model is in production.
